**Additional Notes: Bachelor of Music in Composition**

*It is imperative that students be knowledgeable of curriculum and University requirements. Although faculty and full-time advisors are available for academic advisement, students must assume personal responsibility for academic progress and completion of program.*

Admission

Formal admission to the B.M.-Composition major is contingent upon (1) completion of lower-division theory courses with a “B” average or higher, (2) passing the Undergraduate Listening Examination, (3) submission of a portfolio of compositions prior to the end of the sophomore year, and (4) majority approval of the composition faculty.

Applied Music

Applied lessons are required each term until degree requirements are completed. Students must perform a jury examination at the conclusion of each two-semester sequence of applied music.

Completion by jury of MV\_434\_ series required.

Keyboard principals substitute 6 hours of music electives for Class Piano.

Ensembles

A minimum of 3 ensembles must be 4000 level.

Woodwind and brass freshmen and transfers must register for MUN 2460 during the first Spring and second Fall terms at FSU (string freshmen and freshmen transfers must register during first two Fall terms). Other transfers in these areas must register for MUN 2460/4463 during first Fall term at FSU.

Recital Attendance

Transfers should consult an advisor concerning requirements for student recital attendance (MUS1010).

Course Prerequisites

MUT 1112 is prerequisite to MUL 2110.

MUL 2110 and MUH 2512 are prerequisites to MUH 3211.

MUH 3211 is prerequisite to MUH 3212.

MUT 3421 is prerequisite to MUT 3422.

MUT 2117 and MUT 2247 are prerequisites for all advanced theory courses.

Multicultural Requirement

One X (cross cultural) course and one Y (diversity) course are required. MUH 2512 (required for music majors) is an X course. Students should consider selecting an E-Series course that is also a Y course.

Scholarship in Practice

Two Scholarship in Practice courses (with different prefixes) are required. MUT 2116 (Music Theory III), Internships, Study Abroad, many E-Series courses, Applied Music Lessons plus a Recital in the same semester, and courses taken in the Undergraduate Research Opportunity Program (UROP) may be used to satisfy the Scholarship in Practice requirement. Students in this major should consider taking POS 1041 to fulfill the Liberal Studies Social Science requirement, as it also meets the Civic Literacy requirement. If a different course is taken in Social Science, students may satisfy the Civics requirement by scoring at least 60% on the exemption test.

### **FSU College of Music: Information on Undergraduate Composition Degree**

The B.M. composition degree is for students interested in composition of contemporary "classical" concert music that explores extended tonal and atonal harmonic languages in traditional and novel forms. Students interested in traditional tonal or popular styles of composing should consider the B.A. in commercial music or jazz. Prospective students should look closely at these curricula as they consider their options and interests. Students in the B.A. program may be able to study composition individually if studio space is available.

Students must have completed or exempted MUT 1111 (Theory I) before taking individual lessons in composition. Lessons for credit during the freshman and sophomore year are normally taken with doctoral students. Exceptional students with prior training in composition may, pending approval, obtain lessons with faculty members immediately; others may be invited to study with faculty based on promise shown in studies with a doctoral student.

Any prospective composition student must be admitted to the College of Music and have successfully auditioned on a principal instrument. Students should submit 2-3 compositions for consideration of admission to the composition program. These scores must be received no later than the Monday morning of the week before fall-semester or spring-semester classes begin. Jones, Theory/Composition, College of Music, Florida State University, Tallahassee, FL 32306-1180. Scores will be reviewed and students will be notified about lessons prior to the start of classes.

Students who are at first denied individual lessons for credit are welcome to resubmit their work; they may also seek private instruction. Another option is our "Introduction to Composition" class (offered every spring semester), the completion of which guarantees the availability of individual lessons for credit in future semesters.

Once individual lessons for credit are granted, a student is considered a tentative (lower-division) composition major. Each student's progress and work in private lessons is evaluated at the end of each semester. Students who do not progress well or who demonstrate inconsistent effort will not be permitted to continue in the program. At the end of the sophomore year, students will meet with faculty to discuss their compositions to date, which are submitted to the faculty for admission to the upper-division composition

sequence. This is equivalent to the sophomore "applied" jury. One other requirement for admission to the upper-division sequence is to pass the undergraduate listening exam for composition. Students not admitted to the upper-division level should keep in mind that a B.A. in music is a viable and flexible alternative.
