Bachelor of Music in Performance – Composition

Students are responsible for making successful academic progress and completing their degree programs. To avoid delays, it is imperative that students attend advising sessions regularly and understand degree requirements.

Information on Undergraduate Composition Degree

The BM Composition degree is for students interested in composition of contemporary “classical” concert music that explores extended tonal and atonal harmonic languages in traditional and novel forms. Students interested in traditional tonal or popular styles of composing should consider the BA in Commercial Music or Jazz. Prospective students should look closely at these curricula as they consider their options and interests. Students in the BA program may be able to study composition individually if studio space is available.

Students must have completed or exempted MUT 1111 (Theory I) before taking individual lessons in composition. Lessons for credit during the freshman and sophomore year are normally taken with doctoral students. Exceptional students with prior training in composition may, pending approval, obtain lessons with faculty members immediately; others may be invited to study with faculty based on promise shown in studies with a doctoral student.

Any prospective composition student must be admitted to the College of Music and have successfully auditioned on a principal instrument. Students applying to the Composition program submit 2–3 compositions in their supplemental admissions packet. Current students seeking admission to Composition submit scores by August 1 for fall lessons or by December 1 for spring lessons. Please e-mail your scores to eajones@fsu.edu, or hand-deliver them to Longmire 213B, or mail them to Prof. Evan A. Jones, Theory/Composition, College of Music, Florida State University, Tallahassee, FL 32306-1180. Scores will be reviewed and students will be notified about lessons prior to the start of classes.

Students who are granted individual lessons for credit are welcome to resubmit their work; they may do so at the discretion of the professor. Another option is our "Introduction to Composition" class (offered every spring semester) which guarantees the availability of individual lessons for credit in future semesters.

Once individual lessons for credit are granted, a student is considered a tentative (lower-division) composition major. Each student's progress and work in private lessons is evaluated at the end of each semester. Students who do not progress well or who demonstrate inconsistent effort will not be permitted to continue in the program. At the end of the sophomore year, students will meet with faculty to discuss their compositions to date, which are submitted to the faculty for admission to the upper-division composition sequence. This is equivalent to the sophomore "applied" jury. One other requirement for admission to the upper-division sequence is to pass the undergraduate listening exam for composition. Students not admitted to the upper-division level should keep in mind that a BA in music is a viable and flexible alternative.

Admission

Formal admission to the BM Composition major is contingent upon:

- (1) Completion of lower-division theory courses with a "B" average or higher
- (2) Passing the Undergraduate Listening Examination
- (3) Submission of a portfolio of compositions prior to the end of the sophomore year
- (4) Majority approval of the composition faculty

Supportive Courses in Music

Applied Music

Applied music lessons (private lessons) with a professor or graduate student on the student's primary instrument must be taken every fall and spring until degree requirements are satisfied. Students may be required to perform juries or final examinations as determined by their studio.

Keyboard principals are exempt from class piano but must make up the 6 credits with music electives. Elective courses are defined as any course not already required by the major.

Ensembles

Students must earn a minimum of 6 ensemble credits. Ensembles taken for 0 credit do not satisfy any of the 6 required ensemble credits. Each ensemble has 2 interchangeable course codes: MUN 2___ and MUN 4___, though 3 ensembles should be taken at the 4000 level.

Students receiving music scholarships must participate in an ensemble each fall/spring semester which is listed on their music scholarship contract. Scholarship compliant ensembles may be taken for 0 credit and still fulfill scholarship requirements.

Chamber Music

- Woodwind and Brass principals register for MUN 2460/4463 (Chamber Music) their **1st spring** and **2nd fall** semesters.
- Percussion principals register for MUN 2140/4443 (Percussion Ensemble) for 2 semesters.



Student Recital Attendance

Students must complete 6 semesters of Student Recital Attendance (MUS 1010). To earn a grade of “Satisfactory”, students must earn 15 recital credits by attending college-approved events. Some events may be worth multiple recital credits. Transfer students should consult their advisor regarding required number of semesters.

Class Piano

Students must complete MVK 3131 (Class Piano IIIB) or exempt the requirement through testing. Please see the following sequence for Class Piano:

MVK 1111 A (fall) → MVK 1111 B (spring) → MVK 2121 A (fall) →
MVK 2121 B (spring) → MVK 3131 A (fall) → MVK 3131 B (spring)

Piano principals are exempt from MVK 1111, 2121, 3131 (Class Piano I, II, III) but must make up the 6 credits with music electives.

General Studies

Satisfactory completion of 36 credits of general education courses within the Liberal Studies of the 21st Century program. For more details about each of these requirements, please see: *It's All Academic 2022*: <https://undergrad.fsu.edu/academic-information/its-all-academic>

Quantitative & Logical Thinking (Math)

Students must complete a total of 6 credits in this area including 3 credits from a State Core course with a prefix of either MAC or MGF, and 3 credits of a Quantitative & Logical Thinking course of their choice. This requirement must be completed with a grade of C- or better within the first three semesters of undergraduate study, not including summers.

English Composition

Students must complete a total of 6 credits in this area: ENC 1101 and ENC 2135. This requirement must be completed with a grade of C- or better within the first two semesters of undergraduate study, not including summers. Students transferring in with a completed AA degree from a public Florida institution are exempt from taking ENC 2135. All other transfer students should consult their advisor.

Social Science & History

Students must complete 6 credit hours in the combined area of Social Science and History. 3 of these credits must be a State Core. Since 3 credits for History will be covered by MUH 3211 (Music History I), students must therefore complete 3 credits of a Social Science State Core course. Options include:



- PSY 2012 (General Psychology)
- SYG 1000 (Intro to Sociology)

Humanities & Ethics

Students must complete 6 credit hours in the combined area of Humanities and Ethics. Since MUH 2512 (Music in World Cultures) and MUL 2110 (Survey of Music Literature) fulfill the Humanities requirement, students must complete the only Ethics State Core course: PHI 2010 (Introduction to Philosophy).

Alternatively, if a student has credit for any of the following courses...

- ARH 2000 (Art, Architecture, and Artistic Vision)
- LIT 2000 (Introduction to Literature)
- MUL 2010 (Music Appreciation) – NOT MUL 2110 (Survey of Music Literature)
- HUM 2020 (The Art of Being Human: Examining the Human Condition Through Literature, Art, and Film)
- THE 2000 (Introduction to Theatre)

...they may complete any Ethics course and are not restricted to PHI 2010.

Natural Sciences & Natural Science Lab

Students must complete a total of 7 credits in this area. One of the following Natural Science State Core courses is required:

Writing "W"

Students must complete two Writing "W" courses. The first of these course requirements is satisfied through MUH 3211 (Music History I) with a grade of C- or better. Students are advised to combine the second Writing "W" course with a Diversity course.

Scholarship in Practice & Formative Experience

Students must complete one "SIP" and one "FE" course (An additional SIP course may be substituted for the FE course). This requirement is fulfilled through MUT 2216 (Music Theory III) with a grade of C- or better and MUC 4950 (Composition Senior Recital) with a satisfactory grade (S).

Diversity

Students must complete two Diversity courses in total. One Diversity course is fulfilled with MUH 2512 (Music in World Cultures) or MUH 2051 (Music in World Cultures for Non-majors). Students are advised to combine a Diversity course with a Writing "W" course.

Oral Communication Competency

Students must complete one Oral Communication Competency course. Options for completing this requirement may be found via the following link:

Computer Competency

Students must complete one Computer Competency course. The "Computer Competency" requirement is fulfilled with MUS 2360 (Introduction to Technology in Music) with a grade of C- or better.

Upper-Division Writing

Students must complete one Upper-Division Writing course. The "Upper-Division Writing" requirement is fulfilled with MUH 3212 (Music History II) with a grade of C- or better.



Civic Literacy

Students must complete the Civic Literacy requirement by passing one of the following with a grade of C- or better **AND** passing the Civic Literacy Exam.

- POS1041 (American National Government)
- AMH 2020 (A History of the United States Since 1877)
- Transfer credit from IB History: History of America (score of 5 or higher)

Students who have accelerated credit for the following have their Civic Literacy requirement fully satisfied:

- AP United States History (score of 4 or higher)
- CLEP American Government (score of 50 or higher)

Upper-Division Credit Total

Students must complete a total of 45 credits of upper-division coursework. Upper-division coursework constitutes courses at the 3000 or 4000 level, including music courses. Students are encouraged to seek non-music electives which also fulfill upper-division credits.
